

**DIRECTIONS TO

FROM DOWNTOWN ATLANTA:

Take 85 North to 285 heading West (Spaghetti Junction). Take 285 West to Exit 30 (Chamblee Dunwoody, N. Shallowford, N. Peachtree exit). As you exit the highway, you will come to a traffic light (N. Peachtree).

- go through this traffic light - do not turn left or right - remain on the access road (Cotillion Rd.).
- at the second light (N. Shallowford), turn right.
- follow N. Shallowford until you get to the corner of N. Shallowford, Chamblee-Dunwoody and Peeler roads. There will be traffic light at this intersection, turn right onto Peeler Road and look for the second left turn (Independence Square) and make a left onto Independence Square.

After you enter the complex and look for the building marked "1854." The Independence Square buildings are 2 story red brick "Williamsburg" style office condos. Each building is clearly marked. My office is on the first floor of the 1854 Building, Suite A.

FROM MARIETTA, ROSWELL AND WEST ATLANTA.

Take 285 East to Exit 30 (Chamblee Dunwoody, N. Shallowford, N. Peachtree exit). There is a traffic light as you exit the off ramp. Take a left onto Chamblee Dunwoody Rd. Stay on Chamblee Dunwoody for about 1 mile until you reach the intersection with North Shallowford. You will see a sign for Dekalb Community College at the intersection and a hair salon called "M.T. Heads" on your left. Go through this traffic light (Chamblee Tucker runs into Peeler Rd.) and make your second left onto Independence Square. After you have entered the complex (these are "Williamsburg" style 2 story red brick office condos) look for the building marked "1854." Each building is clearly marked. My office is on the first floor of the 1854 Building, Suite A.

FROM GWINNETT COUNTY, LAWRENCEVILLE.

Take 85 South to 285 heading East (Spaghetti Junction). Take 285 West to Exit 30 (Chamblee Dunwoody, N. Shallowford, N. Peachtree exit).

- As you exit the highway, you will come to a traffic light (N. Peachtree).
- go through this traffic light - do not turn left or right - remain on the access road (Cotillion Rd.).
  - at the second light (N. Shallowford), turn right.
  - follow N. Shallowford until you get to the corner of N. Shallowford, Chamblee-Dunwoody and Peeler roads. There will be traffic light at this intersection, turn right onto Peeler Road and look for the second left turn (Independence Square) and make a left onto Independence Square.

After you enter the complex and look for the building marked "1854." The Independence

#### FROM CONYERS:

Take 20 West to 285 North. 285 North will become 285 West. You will pass through Spaghetti Junction. Take 285 West to Exit 30 (Chamblee Dunwoody, N. Shallowford, N. Peachtree exit).

As you exit the highway, you will come to a traffic light (N. Peachtree).

- go through this traffic light - do not turn left or right - remain on the access road (Cotillion Rd.).

- at the second light (N. Shallowford), turn right.

- follow N. Shallowford until you get to the corner of N. Shallowford, Chamblee-Dunwoody and Peeler roads. There will be traffic light at this intersection, turn right onto Peeler Road and look for the second left turn (Independence Square) and make a left onto Independence Square.

BY MARTA - Take the northbound (Doraville line) MARTA train to the Chamblee station. Take bus number 129 (Chamblee Dunwoody) or bus number 135 (North Shallowford) to Independence Square. I am at 1854 Independence Square, Suite A.
